

AFTER SUCCESS WITH FENTANYL POLICY, **VILLAPUDUA TAKES AIM AT PROP 47**

Assemblymember Carlos Villapudua started the new year with a strong bill proposal to rein in retail theft by targeting Proposition 47, a California law passed by voters in 2014. Prop 47 was intended to provide more proportional punishments for "minor" crimes, but instead fueled an environment of hostility and aggressive, organized theft over the following years.

Villapudua intends to address the rise in retail theft by focusing on four main concerns: 1) enforce against the accumulation of theft over time and repeat offenses, 2) provide discretion for judges to ensure the punishment fits the crime, 3) support rehabilitation efforts for offenders with drug or alcohol addiction to reduce recidivism, and 4) create a more responsive framework for the Legislature to better adapt and revise retail theft law in the future.




AD HOC WORK GROUP TO HOST THIRD PUBLIC MEETING

HUMAN TRAFFICKING AWARENESS MONTH





Last week, Assemblymember Villapudua joined his legislative colleagues, survivors, and leaders in the nonprofit, law enforcement, and trucking industries to show unity and support in combatting human trafficking. The bipartisan coalition emphasized the need for greater publicity, training, and response opportunities for Californians.

"While nobody needs to be convinced of how heinous this crime is, we all need to understand how complicated this issue is, and the types of resources victims and survivors need to escape this vicious cycle for good," Villapudua said. "We must remain committed to working with survivors who can help us craft policy and provide support for those who need it most."

The City of Stockton approved the transfer of a \$400,000 grant for Loads of Hope, a nonprofit that provides free services for local homeless individuals.


Villapudua championed this funding in the 2023 State Budget after seeing the uplifting benefits of their services and the promising impact they will have on our community.
